EPR-REGISTRATION FOR PLASTIC WASTE MANAGEMENT RULES, 2016,
E-WASTE MANAGEMENT RULES, 2022, BATTERY WASTE MANAGEMENT
RULES, 2022

**A. Registration in CPCB - Extended Producer Responsibility (EPR)
portal under Plastic Waste Management Rules, 2016 and its amendments**

As per Plastic Waste Management Rules, 2016 and its amendments the following obligated entities are required to register in Centralized Extended Producers Responsibility Portal for Plastic Packaging <https://eprplastic.cpcb.gov.in/#/plastic/home> implemented by Central Pollution Control Board (CPCB), Delhi

- i. Producer (P) including micro and small enterprises as defined under the Micro, Small and Medium Enterprises Development Act, 2006 (27 of 2006).
- ii. Importer (I).
- iii. Brand owner (BO).
- iv. Plastic Waste Processor (PWP) engaged in (a) recycling, (b) waste to energy, (c) waste to oil, and (d) industrial composting.
- v. Manufacturers and importers of plastic raw material.
- vi. Manufacturers of items made from compostable plastics or biodegradable plastics.

Registration to all the entities will be issued by Puducherry Pollution Control Committee (PPCC) within 30 days and those entities operating more than two states shall obtain registration from Central Pollution Control Board (CPCB), Delhi.

**B. Registration in CPCB - Extended Producer Responsibility (EPR) portal
under E - Waste (Management) Rules, 2022**

As per as per E-Waste (Management) Rules, 2022 every manufacturer, producer, refurbisher and recycler involved in manufacture, sale, transfer, purchase, refurbishing, dismantling, recycling and processing of e-waste or electrical and electronic equipment listed in Schedule I, including their components, consumables, parts and spares which make the product operational. All the above entities are required to register in CPCB EPR portal <https://eprewastecpcb.in/#/>

Registration to all the entities will be issued by CPCB through EPR Portal.

C. Registration in CPCB - Extended Producer Responsibility (EPR) portal under Battery Waste Management (BWM) Rules, 2022

As per Battery Waste Management (BWM) Rules, 2022 every Producers, Recyclers, and Refurbishers of Battery shall have to register through the online centralized portal developed by the Central Pollution Control Board (CPCB). Recyclers and Refurbishers shall also have to register with the concerned SPCB/PCC on this centralized portal developed by CPCB <https://www.eprbatterypcb.in/>

Registration to entities Recycler and Refurbisher will be issued by PPCC and for entities Producer and Importer registration will be issued by CPCB through EPR portal.
